On behalf of the Regents of the University of Minnesota ("UMN"), licensee of noncommercial educational Station KUOM-FM, St. Louis Park, Minnesota, we transmit herewith information concerning the 2014-2015 Sharetime Schedule for Stations KUOM-FM and KDXL(FM), St. Louis Park, Minnesota.

Pursuant to a 1999 Sharetime Agreement, as amended, between UMN and Independent School District No. 283 ("ISD"), licensee of KDXL(FM), and the FCC authorizations in BLED-20030313AGW and BMLD-20020814AAT, ISD operates the station facility during school hours (8 A.M. to 4:30 P.M.) on Designated School Days, and UMN operates the station facility at other times. The Special Operating Conditions in the station licenses in FCC File Nos. BLED-20030313AGW and BMLD-20020814AAT require the submission of a Schedule of Designated School Days each year by August 1.

For Operation of Noncommercial Educational Radio Station KDXL(FM)/KUOM-FM  
pursuant to 1999 Sharetime Agreement (as amended March 24, 2003).**

Pursuant to the Special Operating Conditions in the station authorizations in FCC File Nos. BMLD-20020814AAT and BLED-20030313AGW, Independent School District #283 (licensee of KDXL) and the Regents of the University of Minnesota (licensee of KUOM-FM) submit the following Schedule of Designated School Days for the sharetime operation of noncommercial educational radio Station KDXL(FM)/KUOM-FM:
